VIGIL HONOR NOMINATION DUE BY OCTOBER 1st

Instructions - Please Note:

- 1. The attached form **must** be used to nominate someone for the Vigil Honor.
- 2. A recent photograph of the nominee <u>must</u> accompany this nomination.

 You will be doing your nominee a disservice if you do not attach a photo. Do not assume
 That someone else will send in a photo or that everyone on the Vigil Selection Committee
 knows every nominee by name. A photo helps put a face with a name. <u>Photos will not be returned.</u>
- The nomination form <u>must</u> be complete.
 Do not assume the Vigil selection committee is aware of all your nominee's accomplishments.
- 4. All nominations <u>must</u> be in by <u>October 1st</u>.

 All nominations will remain on permanent file by the Vigil Selection Committee for the current and one additional year.
- 5. To be eligible for the Vigil Honor, the nominee <u>must</u> have been:
 - a. a Brotherhood member in good standing for at least 2 years at the time of nomination,
 - b. currently registered and active with the Indian Nations Council, B.S.A., and
 - c. be currently registered (dues paid) and an active member of Ta Tsu Hwa Lodge #138, Order of the Arrow, B.S.A.
- 6. Remember: Keep this nomination confidential. The nominee <u>must not</u> have knowledge of his/her nomination for the Vigil Honor. A nomination does not mean automatic selection for the Vigil Honor. If selected, he/she will be notified only by the Vigil Selection Committee (currently recognized at the annual Lodge Banquet in a Vigil Call-out Ceremony).
